**PUSHPAY® VIRTUAL TERMINAL  
CREDIT CARD AUTHORIZATION AGREEMENT**

I (we) hereby authorize *Grandview Christian Church* to initiate credit card charges to my (our) credit card account via the Pushpay® Virtual Terminal Service and establish reoccurring gift payments on my (our) behalf as indicated below. This authorization shall remain in effect as indicated below, or until I (we) revoke or modify the authorization which I (we) can do at any time by writing to Grandview Christian Church, 300 University Parkway, Johnson City, TN 37604.

Written notifications to revoke this authorization or to make any changes in my (our) account information and/or gift amounts will be done in such time as to afford the *Grandview Christian Church* a reasonable opportunity to act upon it. I (we) acknowledge that *Grandview Christian Church* must notify Pushpay® at least 2 business days prior to the next transaction date in order to affect any changes. I (we) can stop payment by notifying my (our) credit card company at least 3 days before my (our) account is charged.

If the requested payment date(s) falls on a weekend or holiday, I (we) understand that the payment may be executed on the next business day. I (we) acknowledge that the origination of credit card transactions to my (our) credit card account must comply with the provisions of U.S. law. I (we) will not dispute *Grandview Christian Church's* recurring billing with my (our) credit card so long as the transactions correspond to the terms indicated in this agreement. All Donations and gifts to *Grandview Christian Church* are non-refundable and are for intangible religious benefits. Gifts will be received to the General Fund unless otherwise specified.

I (we) understand that I (we) can establish reoccurring gift payments online without *Grandview Christian Church's* assistance, by using the Pushpay® program at the following web address, <https://pushpay.com/pay/grandviewchristian/recurring> or by using a smartphone to download the Pushpay App by texting "Grandview" to 77977 or by visiting Pushpay.com. I (we) have instead opted to have *Grandview Christian Church* manage this process on my (our) behalf through this written instrument. I (we) understand that should *Grandview Christian Church* ever terminate its relationship with Pushpay® or should the Pushpay® Virtual Terminal program, ever be discontinued by Pushpay®, that this authorization will immediately and automatically expire.
